## GP21/33 TO RECEIVE AN UPDATE ON THE ALLOTMENT SITES AND AGREE FURTHER ACTION

- a) To review the quotes received to resurface the entrance to Rotherham Road allotments. Council members were provided with three quotes: Ongoing.
- b) To discuss the issues and requests raised by tenants of Limesway allotments.

Cllr Kirk granted a member of the public permission to speak.

A member of the public complained about the process experienced when applying for an allotment and the length of time the Council had taken to allocate him a plot on Limesway allotment site. The member of the public also disputed the access route given to the allotment site secretary. The member of the public had also written to the Council to request retrospective permission for a raised water butt, potting table, and fencing.

Members of the public were asked to leave the meeting to allow Councillors to discuss the matter.

Council members were also provided with a letter from another allotment holder which raised concerns with the actions of another tenant.

Councillors discussed all matters and resolved the following:

**APPROVED**: Permission for the water butt providing the structure is deemed secure.

**APPROVED**: Permission for the potting table providing the height does not exceed waist level.

**REFUSED**: The request for fencing as the Council have started looking for quotes to carry out the work.

**REFUSED**: The request to stop the allotment secretary accessing the site from the southern end of the site. Access will be permitted until 31<sup>st</sup> March 2022. The tenant of plot one will be requested to reinstate the path at the eastern boundary of the plot.

Cllr Dickinson left the meeting.
